On September 17, 2019, Spire Missouri filed substitute tariff sheets based upon Staff's suggested edits to the company's WNAR tariff sheets. Staff reviewed the WNAR adjustment calculations and filed a recommendation and report recommending Commission approval of the substitute tariff sheets.
