NOTICE ACCEPTING REPORT AND CLOSING FILE

The Commission opened this file on November 28, 2018, at the request of its Staff to facilitate Staff's investigation of the Lifeline program practices of American Broadband and Telecommunications Company d/b/a American Assistance.

In requesting this investigation be opened, Staff explained its concern that American Assistance has been investigated by the Federal Communications Commission regarding allegations that the company has committed repeated, systematic and large-scale violations of FCC rules governing the Lifeline program. Staff intended to investigate whether American Assistance has violated any laws applicable to its provision of Lifeline service in Missouri, and would report its findings to the Commission.

Staff filed a report regarding the results of its investigation on September 9, 2019. Staff found many incidences of American Assistance failing to produce required enrollment documentation and enrolling subscribers with noncompliant proof of eligibility documentations. As a result of its findings, Staff intends to file a separate complaint with the Commission asking that American Assistance's ETC status be revoked.

As the Commission indicated in its order opening this investigation, this is only a fact-finding investigation and is not a contested case. The Commission will not take any action regarding American Assistance within the confines of this investigation. If Staff believes that Commission action is needed as a result of the investigation, it may file a formal complaint or other appropriate pleading within a new file to institute contested case procedures.

Since Staff's investigation is now complete, the Commission will close this file and await further action by Staff in an appropriate case.
