## ORDER CANCELING REGISTRATION

Issue Date: September 25, 2024

Effective Date: October 5, 2024

On September 11, 2024, XCast Labs, Inc. filed a letter seeking to cancel XCast Labs, Inc.'s registration to provide Interconnected Voice over Internet Protocol service ("IVoIP") in the State of Missouri. The Commission granted XCast Labs, Inc. its IVoIP registration in the State of Missouri in File No. DA-2022-0222.

The Commission need not hold a hearing, if, after proper notice and opportunity to intervene, no party requests such a hearing.<sup>1</sup>

Based on XCast Labs, Inc.'s request, the Commission finds that the IVoIP registration granted to XCast Labs, Inc. shall be canceled.

### IT IS ORDERED THAT:

1. The registration to provide Interconnected Voice over Internet Protocol services, granted to XCast Labs, Inc. in File Number DA-2022-0222, is canceled.
2. This order shall become effective on October 5, 2024.
3. This case may be closed on October 6, 2024.
