On August 30, 2024,<sup>1</sup> Liberty Utilities (Midstates Natural Gas) Corp d/b/a Liberty (MNG) filed proposed revisions to its Weather Normalization Adjustment Rider (WNAR) tariff sheets in Tracking No. JG-2025-0021. The tariff sheets bear an October 1 effective date.

The purpose of the WNAR tariff sheets is to adjust revenues, either positive or negative, for differences between actual heating degree days and normal heating degree days for the six-month period ending April 1, 2025. The tariff sheets filed are a mandatory semi-annual filing pursuant to Liberty's WNAR tariff.

On September 18, the Staff of the Commission (Staff) filed its Recommendation. Staff reviewed the tariff sheets and corresponding workpapers and weather data, and recommended approval of the tariff sheets. Staff explained that the WNAR adjustment

would increase the average monthly bill, based on 100 Ccf<sup>2</sup> of natural gas usage in a

given billing month, of the typical residential customer by approximately:

- \$2.31 per month in the Northeast and West District; and
- \$0.80 per month in the Southeast District.

The increases for a small general service class customer using 100 Ccf of natural gas would be approximately:

- \$0.84 per month in the Northeast and West District; and
- \$0.19 per month in the Southeast District.

The Commission set a time for responses to the application or Staff's recommendation for approval.<sup>3</sup> No party responded, and no party opposed approval of the tariff sheets. The Commission has reviewed the tariff sheets and Staff's Recommendation and Memorandum and finds that the tariff sheets should be approved. Based upon Staff's verified Recommendation, the Commission will take no action regarding the tariff sheets filed on August 30, assigned Tracking No. JG-2025-0021, and gives notice that those tariff sheets will go into effect by operation of law on October 1. The tariff sheets going into effect are:
