On June 24, 2024 Adhol W. Deng filed a complaint before the Commission. An Order was issued on July 1, 2024, directing the filing of an Answer. Staff was directed to file its investigative report or a status report by August 16, 2024. On August 1, 2024, Spire filed an Answer and a Motion for Partial Dismissal. On July 2, 2024 and August 2, 2024, Staff filed data requests with due dates of August 22, 2024. On August 13, 2024, Staff filed a Motion for Extension of Time, asking that the Commission give them until September 20, 2024 to complete and file their report. Staff states that all parties were apprised of the Motion and none objects. The Commission granted the Motion for Extension of Time. Staff filed a Report and Recommendation on September 19, 2024. A prehearing conference is now appropriate so the parties may discuss whether a hearing is needed and, if so, what dates would be appropriate for that hearing.

THE COMMISSION ORDERS THAT:

1. The Commission will convene a prehearing conference on November 5, 2024, at 10:00 a.m., via WebEx. The Commission will send parties information needed to access WebEx for the conference via email.
2. This order shall be effective when issued.
