**ORDER DIRECTING COMPLAINANT TO SHOW CAUSE  
WHY COMPLAINT SHOULD NOT BE DISMISSED**

On September 6, 2024, the Commission issued an order setting a prehearing conference in this matter for September 25, 2024, at 2:00 p.m., to be conducted via WebEx telephone and video conference. Counsel for Evergy Missouri West, Inc. d/b/a Evergy Missouri West and counsel for the Staff of the Commission appeared for the hearing at the scheduled date and time. Complainant Kevin Kojeski did not appear.

Per Commission Rule 20 CSR 4240-2.090(5), "Failure to appear at a prehearing conference without previously having secured a continuance shall constitute grounds for dismissal of the party or the party's complaint . . . unless good cause for the failure to appear is shown." The Commission will order Mr. Kojeski to file a pleading showing cause as to why his complaint should not be dismissed.

**THE COMMISSION ORDERS THAT:**

1. Complainant Kevin Kojeski shall file a pleading no later than October 9, 2024, showing cause why his complaint against Evergy Missouri West should not be dismissed for failure to appear.
2. This order is effective when issued.
