

1. All court proceedings, except for legitimate criminal action where there is an injured living soul, are under Admiralty or Maritime jurisdiction, are either insurance or contract related, and are dischargeable with either a signature of a living soul, or another debt instrument comprised of a promise to pay, payment being an impossibility.

ADMIT - Unless properly rebutted, all facts stated in Point 8 stand as truth.

9. This court, [TO MISSOURI SUPREME COURT], is, in fact, proceeding in "in forma pauperis", with no substance in fact, or in law, no jurisdiction over any living soul where an actual (real) crime has not been committed. IF THERE IS NO CORPUS DELECTI (dead corpsc) THERE IS NO CASE.

ADMIT - Unless properly rebutted, all facts stated in Point 9 stand as truth.

10. All "funds" of various debt instruments acquired by this court have been <u>co-mingled</u> in I.O.T.A. or I.O.L.T.A. and <u>cannot stand up to the scrutiny of U.S. Treasury directives</u>.

ADMIT – Unless properly rebutted, all facts stated in Point 10 stand as truth.

The Commission stated I failed to make a claim.

- 1. I claimed that Paying with FRN is an obligation.
- 2. Paying with FRN is an obligation because of HJR 192, Remittance Transfer is acceptable with using my living signature on the coupon itself and returning Accepted For Value and using FRN is an obligation.

- 3. Since clause HJR 192, acceptable and using FRN is an obligation. My signature is signed on said bills, All Accounts Are Prepaid.
- 4. Although some might argue that it is legal tender to pay debts, it is not, it's colorable and we do not pay debts with silver or gold coins. It cannot mean a promissory note, certificates, notes or any other means to pay debts. As noted on my Affidavit that all debts are Prepaid. The government has the obligation to pay these debts being they are the ones printing the fiat paper.

I seek remedy to the injury that has been caused by these corporations by disconnecting an essential need that they treat as goods and products. The Utility Corporations never produced a contract stating that I contracted with them. It was done on false pretenses that we must provide our name, Social Security number and an address for services. Per my Affidavit Notice of Liability Regarding Trespass and Schedule Fee and Remedy for Trespassing against the Sovereign and continue to disconnect for a non-payment. They all are committing fraud.
