## ORDER DIRECTING NOTICE, ESTABLISHING A DEADLINE FOR FILING REQUESTS TO INTERVENE AND SETTING PRE-HEARING CONFERENCE

On September 20, 2013, Kansas City Power & Light Company and KCP&L Greater Missouri Operations Company ("Companies") filed an application for an Accounting Authority Order that would allow the Companies to undertake certain accounting procedures in connection with transmission costs associated with the Southwest Power Pool. A proposed procedural schedule was supplied by the Companies.

The Commission will direct notice and will establish a deadline for applications to intervene. A pre-hearing conference will be scheduled so the parties may discuss a procedural schedule and the potential resolution of any unresolved issues.

- 4. Any person or entity wishing to intervene shall file an appropriate pleading no later than October 2, 2013, with:

- 5. Any objections to a timely filed application to intervene shall be filed with the Commission no later than October 4, 2013.
- 6. A pre-hearing conference will be held at 2:00 p.m. on October 7, 2013, at the Commission's office at the Governor Office Building, 200 Madison Street, Jefferson City, Missouri, Room 305. This building meets accessibility standards required by the Americans with Disabilities Act.
