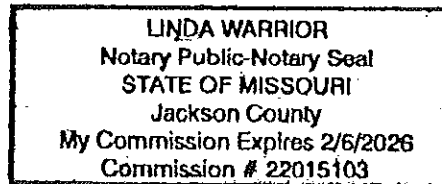

Over the years, I have been receiving these statements from your corporation(s) addressed to my all-caps cestui que trust name SHAMERA WILLIAMS and/or SHAMERA E WILLIAMS. Your statements include a bond with a coupon attached to it. I have only recently realized what these words mean. Please see the definitions below from the Black's Law Dictionary, 3rd Edition.

Statement - Black's Law Dictionary 3rd Edition: "An allegation"

Coupon - Black's Law Dictionary 3rd Edition: "Coupons are written contracts for the payment of a definite sum of money on a given day, and being drawn and executed in a form and mode for the purpose, that they may be separated from the bonds and other instruments to which they are usually attached."

Bond - Black's Law Dictionary 3rd Edition: "A contract by specialty to pay a certain sum of money"

Instrument - Black's Law Dictionary 3rd Edition: "A written document; a formal or legal document in writing, such as a contract, deed, will, or lease."

Now, I have been returning all the mail at hand to the sender (RTS) Return to Sender- writing "**NO CONTRACT**"- The presentment is dishonored. And now, it has come to my attention that your corporations have been sending myself these statements, my parent(s), family & siblings, sending I/me/myself/us/we/ourselves of the Williams/Bowen/Young/McClinton Family these statements all these years attached to them money orders in the past reserving all of my rights on all the said money orders and/or paying by electronic funds transfer. The cestui que trust, **SHAMERA WILLIAMS** and/or **SHAMERA E WILLIAMS**, was set up to pay all of my bills. All accounts are pre-paid.

And because you all have my social security number and Certificate of Birth for identification purposes only, not a corporation (a dead corpse) as the PSC Commission has stated, what is taking place is a Trust

Action - with me as the beneficiary and with **EVERGY, SPIRE & THE WATER SERVICES** 'aka' City Hall as the trustee. As the trustee, I would like to remind you that you, the authorized representative of **EVERGY, SPIRE, & THE WATER SERVICES** have the fiduciary obligation to act in a way that will benefit me, the beneficiary. However, that has not been what has been happening. I/Me/Myself/Us/We/Ourselves, Sha'Mera-Elisa: of Williams sui juris, the undersigned affiant, a living woman declare that I am of majority and competent to state the matters set forth herein with first-hand knowledge of the facts and that they are true, correct, not misleading, and certain, admissible as evidence:

- **Senate Document No. 43, 73rd Congress** "The ownership of all property is in the State. Individual, so-called ownership is only by the virtue of the government, i.e. law, amounting to mere user, and use must be in accordance with law, and subordinate to the necessities of the state."
- **Congressional Record, March 9th, 1933 on HR 1491, p.83** "Under the new law, the money is issued to the banks in return for government obligations, bills-of- exchange, draws, notes, trade acceptances, and bankers' acceptances. The money will be worth 100 cents on the dollar, because it is backed by the credit of the nation. It will represent a mortgage on all the homes, and other property of the people of the nation.

AFFIDAVIT THAT ALL ACCOUNTS ARE PREPAID

Title 18 § 8. Obligation or other security of the United States denied The term "obligation or other security of the United States" includes all bonds, certificates of indebtedness, national bank currency, Federal Reserve notes, Federal Reserve bank notes, coupons, United States notes, Treasury notes, gold certificates, silver certificates, fractional notes, certificates of deposit, bills, checks, or draws for money, drawn by or upon authorized officers of United States, stamps and other representatives of value, of whatever denomination, issued under any Act of Congress, and canceled United States stamps.

FRN's are obligations of UNITED STATES: HJR 192: "The term "obligation" means Federal Reserve notes and circulating notes of Federal Reserve banks national banking associations.

Title 31 § 3123 makes a statutory pledge of the United States government to payment of obligations and interest on the public debt.

Title 31 § 3123. Payment of obligations and interest on the public debt (A) The faith of the United States Government is pledged to pay, in legal tender, principal and interest on the obligations of the Government issued under this chapter. (B) The Secretary of the Treasury shall pay interest due or accrued on the public debt. As the Secretary considers expedient, the Secretary may pay in advance interest on the public debt by a period of not more than one year, with or without a rebate of interest on the coupons. Therefore, the government pledges to pay government obligations which Federal Reserve Notes are, and pay them with FRNs, which is legal tender. Taxes and all bills associated with corporations are all government obligations which they must pay when we accept them for value and return them to the government that has an obligation to settle the debt, dollar for dollar.

- The Constitution does not give we, the people "rights." It forbids the government to ignore the "God given Rights of the people," as seen in the 9th Amendment: "The enumerate the government to ignore the "God given Rights of the people," as seen in the 9th Amendment: "The enumeration in the Constitution, of certain rights, shall not be construed to deny or disparage others retained by the people". In addition, the 10th Amendment: "The powers not delegated to the United States by the Constitution, nor prohibited by it to the States, are reserved to the States respectively, or to the people".

It is a fact: Title 31 § 3130 further delineates in its definitions a portion of the total public debt, which is held by the public as the "Net public debt," § 3130. Annual Public Debt Report (a) General Rule. — On or before June 1 of each calendar year after 1993, the Secretary of the Treasury shall submit a report to the Committee on Ways and Means of the House of Representatives and the Committee on Finance of the Senate on— (1) the Treasury's public debt activities, and (2) the operations of the Federal Financing Bank. For whatever reason we can associate with their actions and reasons they did so, we may benefit. We are beneficiaries, the government are trustees; Trustees pay debts, beneficiaries do not. Thus, government obligations are not taxable.

In fact, by the 14th Amendment, § 4, we need people to create credit instruments. We must also Accept for Value, the debt instruments/legal tender of the United States. As long as the debt exists, the Democracy exists. The Republican Form of Government, The United States of America, can only come back when the debt is gone. Since Federal Reserve Notes (FRN's) as legal tender are debt notes, an insufficient number exist for
