**PUBLIC COUNSEL’S REQUEST FOR EXTENSION OF TIME**

**COMES NOW** the Office of the Public Counsel and for its Request for Extension of Time states as follows:

1. On September 20, 2013, Kansas City Power & Light Company and KCP&L Greater Missouri Operations Company (“the Companies”) filed a joint application for Accounting Authority Orders.
2. On September 26, 2013, the Office of the Public Counsel and the Staff of the Commission jointly filed a Response of Public Counsel and Staff to Proposed Procedural Schedule and Request for Waiver, in which they requested an October 14, 2013 deadline to file responses to Companies’ request for waiver of 4 CSR 240-4.020(2) and proposed procedural schedule.
3. The Commission granted this request by order issued September 27, 2013. At the prehearing conference held on October 7, the presiding officer directed that any request for a further extension be filed no later than October 10.
4. Although the parties have been discussing the possibility of filing an agreed-upon schedule, as of the filing of this motion, no agreement has been reached. In order to allow further discussion about the possibility of filing an agreed-upon schedule, Public Counsel seeks a

four-day extension of the deadline established for responses to the Companies' request for waiver of 4 CSR 240-4.020(2) and the Companies' proposed procedural schedule.

**WHEREFORE**, Public Counsel respectfully requests that the Commission extend the October 14, 2013 deadline for filing responses to the request for waiver of 4 CSR 240-4.020(2) and to the proposed procedural schedule until October 18, 2013.
