On December 12, 2023, Southway Storage, LLC filed an application requesting that its electric supplier be changed from The Empire District Electric Company d/b/a Liberty to White River Valley Electric Cooperative, Inc. On September 27, 2024, Southway Storage filed a voluntary dismissal of the complaint. The Notice of Dismissal of Application states the matter has been settled as between Southway Storage and Liberty.

Commission Rule 20 CSR 4240-2.116(1) states that a complainant may dismiss a complaint without an order of the Commission before prepared testimony or oral evidence has been offered.
