**NOTICE THAT THE COMMISSION DOES NOT PRESIDE OVER  
APPEALS OF COMMISSION ORDERS**

Issue Date: September 27, 2024

On August 7, 2024, the Commission issued its *Report and Order* in this complaint. That *Report and Order* became effective on September 6, 2024. The Commission denied Dranel Clark and Aquilla Canada’s applications for rehearing on September 19, 2024. Dranel Clark and Aquilla Canada later filed a request for appeal of the Commission’s decision in File No. EC-2024-0111 with the Commission on September 26, 2024.

The Commission does not hear appeals of Commission orders, the Missouri Court of Appeals hears appeals of the Commission’s orders. Accordingly, the Commission is an improper forum for the pursuit of an appeal of the Commission’s September 6, 2024 *Report and Order*.

If the Complainants wish to appeal the Commission’s decision, they must file a notice of appeal within thirty days of the effective date of this order in the appropriate appellate court in accordance with Section 386.510, RSMo.
