On September 27, 2024, Liberty Utilities (Midstates Natural Gas) d/b/a Liberty filed a request to extend the filing date for the List of Issues, List of Exhibits, Order of Witnesses, Opening Statements, and Cross Examination. The List of Issues, List of Exhibits, Order of Witnesses, Opening Statements, and Cross Examination had been ordered to be filed September 27. The request stated that the parties have been participating in the scheduled Settlement Conference and that the proposed extension would allow the parties to focus on those discussions.
