## **NOTICE OF COMPLETION**

**COMES NOW** Confluence Rivers Utility Operating Company, Inc., ("Confluence Rivers") and for its *Notice of Completion* states as follows to the Missouri Public Service Commission ("Commission"):

1. On January 31, 2024 (effective February 10, 2024), the Commission issued its *Order Approving Acquisition of Assets and Granting Certificate of Convenience and Necessity* ("Order") in this case. The Order approved the acquisition of, and grants a Certificate of Convenience and Necessity for, the sewer assets of North Oak Sewer District, Inc. ("North Oak"). On August 1, 2024, Confluence Rivers closed on the sewer utility assets of North Oak.

2. Among other things, the Order requires Confluence Rivers 'to complete cleaning, vegetation removal, solid waste disposal, and address other deferred maintenance within 60 days of closing."

3. Confluence Rivers hereby provides notice to the Commission that it has completed the above tasks as of the dates reflected below:

Solid Waste Disposal	Both the digester and aeration chamber were pumped out to remove accumulated sludge that had settled at the bottom of the plant, resulting in approximately 40 truckloads being removed.	9/18/24
Deferred Maintenance	<ul> <li>A new blower and motor have been installed, along with a new duplex panel that includes all the necessary components.</li> <li>The handrails have been painted.</li> <li>Air drops and diffusers were inspected to verify their performance and replaced as necessary.</li> <li>The area around the outfall weir has been cleaned, along with the ditchline that flows to the creek.</li> </ul>	9/26/24
