On September 26, 2024, the Commission held a discovery conference to address Ameren Missouri's *Statement of Discovery Disagreement or Concern*. During the conference, the Regulatory Law Judge ordered any responses to Ameren Missouri's filing to be filed by October 1, 2024. The parties also requested a second Discovery Conference during the week of September 30 to October 4, 2024.

Accordingly, the Commission will order the parties to file available dates for a discovery conference to be held during the week of September 30 to October 4, 2024.

### THE COMMISSION ORDERS THAT:

1. Any responses to Ameren Missouri's *Statement of Discovery Disagreement or Concern* shall be filed no later than October 1, 2024.
2. No later than October 1, 2024, all parties shall file the dates when they will be available for a discovery conference to be held via WebEx, during the week of September 30 to October 4, 2024.

3. This order shall be effective when issued.
