## **REQUEST FOR ADDITIONAL TIME**

**COMES NOW** Spire Missouri Inc. ("Spire Missouri" or the "Company") and respectfully submits this *Request for Additional Time* to the Missouri Public Service Commission ("Commission"), stating the following:

- 1. On April 16, 2024, Staff of the Commission ("Staff") filed a Formal Complaint as a follow-up to its investigation in Docket No. GS-2022-0261.
- 2. On April 23, 2024, the Commission directed Spire Missouri to file an answer to the Formal Complaint no later than May 23, 2024.
- 3. Spire Missouri has requested extensions to file its answer in order to allow the Company and Staff to reach a resolution in this case. The current deadline for its answer or a status update is September 30, 2024.
- 4. Spire Missouri has provided its plan to improve locate timeliness to Staff and received feedback on that plan. Spire Missouri has since sent a revised version of the plan, along with a draft stipulation for Staff to review and provide further feedback. Therefore, the Company requests the Commission extend the time for the Company to file its answer or a status update until October 31, 2024. Staff has been notified of the request and does not object.

**WHEREFORE**, Spire Missouri respectfully requests that the Commission direct the Company to file its answer or a status update no later than October 31, 2024, and order any other relief as is just and reasonable.
