**STAFF STATUS REPORT AND MOTION FOR  
EXTENSION OF TIME TO FILE ITS RECOMMENDATION**

**COMES NOW** the Staff of the Missouri Public Service Commission ("Staff"), by and through counsel, and for its *Status Report and Motion for Extension of Time to File its Recommendation* states as follows:

1. On September 6, 2024, Union Electric Company d/b/a Ameren Missouri ("Ameren") filed a tariff sheet to revise its weather normalization rider ("WNAR") rates for its Residential Customers. The tariff sheet has an issue date of September 2, 2024, an effective date of November 1, 2024, and was assigned Tracking No. JG-2025-0025.
2. On September 6, 2024, the Commission issued an order directing Staff to file a recommendation regarding the tariff sheet no later than October 3, 2024.
3. Upon Staff's review of a spreadsheet summarizing Ameren's Weather Normalization Adjustment reconciliation provided to Staff via email on September 9, 2024, and weather data previously provided by Staff to Ameren, Staff discovered data inconsistencies.
4. On September 20, 2024, Staff notified Ameren of these inconsistencies via email and requested a joint review between Ameren and Staff.

5. On September 27, 2024, as a result Ameren and Staff's joint review on September 26, 2024, Ameren provided detailed files regarding the data and calculations used for their Weather Normalization Adjustment.

6. Additional time is required to review this new information, determine the source of data inconsistencies, and provide a sound recommendation.

**WHEREFORE**, Staff recommends the Commission issue an order granting Staff additional time to review and analyze the newly submitted revised tariff sheet and its associated workpapers; and order Staff to submit its recommendation no later than noon on October 11, 2024.
