STATUS REPORT

COMES NOW Spire Missouri Inc. (“Spire Missouri” or the “Company”), and respectfully submits this Status Report, stating the following:

1. On August 29, 2024, the Missouri Public Service Commission (“Commission”) directed Spire Missouri, Staff of the Commission (“Staff”), and the City of Kansas City (“City”) to file a status report, a settlement agreement, or a request for extension of time no later than September 30, 2024.

2. Since the last status report, the parties have continued discussions and held an on-site meeting on September 20, 2024, at Kansas City International Airport to examine the gas infrastructure in place. The parties continue to work towards a settlement agreement but require additional time to finalize such agreement.

3. The parties agree that an extension is appropriate to continue working on resolving this docket.

4. The parties agree that the Commission should direct the parties to file a status report, a settlement agreement, or a request for extension of time no later than October 31, 2024.

5. Spire Missouri has the approval of both Staff and the City to make the above statements and file this status report.

WHEREFORE, Spire Missouri respectfully requests the Commission direct the parties to file a status report, a settlement agreement or a request for extension of time no later than October 31, 2024, and grant any other relief as is just and reasonable.
