**ORDER DIRECTING NOTICE, SETTING INTERVENTION DEADLINE,
AND DIRECTING STAFF TO FILE RECOMMENDATION**

On September 26, 2024, Teleport Communications America, LLC (“Teleport”) filed an application pursuant to 47 C.F.R. 52.15(g)(3)(iv) requesting that the Commission review and reverse the decision of the North American Numbering Plan Thousands-Block Pooling Administrator to deny Teleport’s request for 3,000 consecutive numbers in the Jefferson City Rate Center.

The Commission finds that proper persons should be allowed to file a request for intervention or a motion for hearing. Therefore, the Commission will set a time for interventions as directed below. The Commission will also direct its Data Center to send a copy of this order to each certificated interexchange and basic local exchange telecommunications company in Missouri. In addition, the Data Center shall send a copy of this order to the North American Numbering Plan Administrator.

The Commission will also direct its Staff to file a recommendation and will establish a date by which any other party wishing to respond must file a recommendation.

THE COMMISSION ORDERS THAT:

1. The Data Center shall send a copy of this order to each certificated interexchange and basic local exchange telecommunications company in Missouri and to the North American Numbering Plan Administrator.
2. Any party wishing to intervene or to request a hearing shall do so no later than October 10, 2024.
3. The Staff of the Commission shall file a recommendation regarding the application of Teleport, or shall file a status report indicating when a recommendation will be filed, no later than October 17, 2024.
4. Any other party that wishes to file a recommendation regarding the application of Teleport shall do so no later than October 10, 2024, and shall file its recommendation simultaneously with its application to intervene.
5. This order shall be effective when issued.
