## ORDER DIRECTING NOTICE, SETTING INTERVENTION DEADLINE, AND ADDING A PARTY

Issue Date: October 2, 2024

Effective Date: October 2, 2024

This order provides notice of this application to interested parties, establishes a deadline for intervention and for requesting a hearing, and joins the other party to the Interconnection Agreement, Alma Communication Company d/b/a Alma Telephone, as a party to this proceeding.

On September 9, 2023, Green Hills Area Cellular, Inc. d/b/a Green Hills Communications, filed an application with the Commission for approval of a negotiated Interconnection Agreement (Agreement) with Alma Telephone under the provisions of the Federal Telecommunications Act of 1996 (the Act). Green Hills Communications stated that there are no unresolved issues and that the Agreement complies with Section 252(e) of the Act in that it is consistent with the public interest, convenient and necessary, and is not discriminatory to nonparty carriers.

Although Alma Telephone is a party to the Agreement, it did not join in the application. Because Alma Telephone is a necessary party to a full and fair adjudication of this matter, the Commission will add Alma Telephone as a party to this case.

The Act provides that the Agreement must be approved unless the state commission finds that the Agreement discriminates against a telecommunications carrier not a party to the Agreement, or that implementation of the Agreement is not consistent with the public interest, convenience, and necessity.<sup>1</sup> Section 252(e)(4) of the Act provides that if the Commission has not acted to approve or reject an Agreement within 90 days after submission, the Agreement shall be deemed approved. That date is December 8, 2024.

The Commission finds that proper persons shall be allowed 10 days from the issuance of this order to file a motion for hearing. The Commission also finds that notice of this application shall be sent to all interexchange and local exchange telecommunications companies. The Staff of the Commission (Staff) will be directed to provide a recommendation.

**THE COMMISSION ORDERS THAT:**

1. The Commission's Data Center shall send notice to all interexchange and local exchange telecommunications companies.
2. Alma Telephone is made a party to this case.
3. Any party wishing to intervene or request a hearing shall do so by filing a pleading no later than October 12, 2024.
4. Staff shall file a recommendation, or a status report regarding when Staff anticipates filing its recommendation, no later than October 24, 2024.
5. This order shall be effective when issued.
