ORDER REJECTING TARIFF SHEETS

Issue Date: October 2, 2024

Effective Date: October 12, 2024

On November 29, 2023, Spire Missouri Inc. d/b/a Spire filed an application for approval of a Carbon Offset Initiative. Along with its application, Spire Missouri filed tariff sheets, Tracking No. JG-2024-0073, to implement the program. The tariff sheets bore a December 29, 2023, effective date.

On December 21, 2023, the Commission issued an order suspending the tariff sheets until April 27, 2024. On April 5, 2024, the Commission further suspended the tariff sheets until October 27, 2024.

On July 18, 2024, the Commission issued its *Order Approving Stipulation and Agreement Regarding Carbon Offset Initiative* (Order). The stipulation and agreement included a specimen tariff representing the agreement between Spire and the Staff of the Commission of how Spire would operate the Carbon Offset Initiative program. The Order authorized Spire to file tariff sheets to implement the program complying with the stipulation and agreement.

On July 30, 2024, counsel for Spire sent an e-mail to the presiding judge and the other parties in the case stating that Spire does not plan to file tariff sheets to implement the program until Spire determines an exact date of program implementation, expected to be in November 2024. To prevent the original tariff sheets, filed on November 29, 2023, from taking effect by operation of law on October 27, 2024, the Commission will reject

those tariff sheets. For the same reason, the Commission will make this order effective in less than 30 days.

THE COMMISSION ORDERS THAT:

1. The tariff sheets filed by Spire on November 29, 2023, and assigned Tracking No. JG-2024-0073, are rejected by the Commission.
2. This order shall be effective on October 12, 2024.

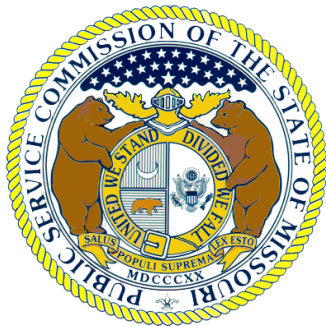
