The Commission has undertaken this rulemaking to require that applications sent to the Commission requesting that the commission grant a certificate of convenience and necessity must meet the requirements set forth in this rule. In addition to proposing a new rule, the Commission is proposing to rescind 20 CSR 4240-3.305 because most of that rule is being rewritten and moved to the proposed rule.

The Commission finds that the rule and rescission are necessary to protect the public interest and to carry out the purposes of the statute that granted the rulemaking authority. The Commission will seek further comments from interested stakeholders during the rulemaking process.

THE COMMISSION ORDERS THAT:

1. The Secretary of the Commission shall file the proposed rule and proposed rescission with the Secretary of State for publication in the Missouri Register as a proposed rulemaking.
2. This order shall be effective when issued.
