# ORDER DISMISSING MATTER

Issue Date: October 3, 2024 Effective Date: October 14, 2024

On June 13, 2023, Leon Travis Blevins (Blevins) applied for a certificate of convenience and necessity (CCN) for several water systems in Pulaski County. Blevins was also a party in File Nos. WC-2023-0353 and WO-2024-0036, which also involved those water systems. Blevins stated multiple times in both of those cases that he wished to dismiss his request for a certificate. However, Blevins never filed a motion to dismiss in this matter.

On September 6, 2024, the Commission issued *Order Setting a Deadline for Blevins to Show Cause Why this Matter Should Not be Dismissed*. The Commission gave Blevins until September 16, 2024, to file any reasons that this matter should not be dismissed. No reasons were filed.

Commission Rule 20 CSR 4240-2.116(4) provides that the Commission may dismiss a case for good cause found after ten days' notice to the parties. Therefore, the Commission will dismiss this case.

## THE COMMISSION ORDERS THAT:

- 1. This matter is dismissed, and this case shall be closed
- 2. This order shall be effective October 14, 2024.
