ORDER SUSPENDING PROCEDURAL SCHEDULE

On July 24, 2024,¹ the Commission issued an order establishing a procedural schedule in this matter. On August 7, the Commission issued an order amending the procedural schedule.

On October 3, all parties in this matter filed a *Joint Motion to Suspend Procedural Schedule*. The motion states that Union Electric Company d/b/a Ameren Missouri, the Staff of the Commission, and the Consumers Council of Missouri have reached agreement on the terms of a settlement that resolves all issues in this case and that the Office of the Public Counsel does not oppose. A formal stipulation and agreement is expected to be filed in a few business days. Given the potential settlement, the joint movants do not expect a contested hearing will be necessary to resolve the case and, therefore, move for the suspension of the procedural schedule.

The Commission will grant the motion and suspend the procedural schedule.

THE COMMISSION ORDERS THAT:

1. The parties' motion is granted. The procedural schedule in this matter is suspended until further order of the Commission.
