The Missouri Public Service Commission is vacating the *Order Granting Expedited Treatment, Overruling Objection, and Approving Compliance Tariffs*.¹

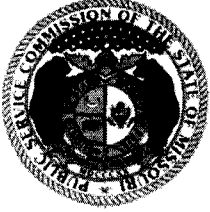
THE COMMISSION ORDERS THAT:




