On August 27, 2024,<sup>1</sup> Confluence Rivers Utility Operating Company, Inc. (Confluence Rivers) and Missouri-American Water Company (MAWC) jointly filed an application requesting that the Commission approve the sale and purchase between them of nineteen small wastewater systems.

The Staff of Commission (Staff) was directed to file a recommendation or a status report indicating when it expected to file its recommendation no later than October 9. On October 3, Staff filed a request for an extension to December 9 to file its recommendation.
