The Commission opened this file on March 27, 2019, to facilitate the Manager of the Manufactured Housing and Modular Units Program of the Public Service Commission's investigation into the installation and set-up practices of Brune Mobile Sales, a certified dealer of manufactured housing units. The Commission's order opening that investigation directed the Commission's Staff to file a progress report regarding that investigation no later than September 27, 2019.

Staff filed a motion on September 24, 2019, asking that it be allowed an additional 30 days to file its progress report. The Commission will grant that request.


