### ORDER DIRECTING FILING

Issue Date: September 26, 2019 Effective Date: September 26, 2019

On September 12, 2019,<sup>2</sup> KCP&L Greater Missouri Operations Company ("GMO") filed a *Response to Order Directing Filing* and advised the Commission the parties had agreed it was unnecessary to try auxiliary power issues in this proceeding and GMO would not seek recovery of amounts associated with Sibley fuel transfer in accumulation period 24 or any other accumulation period. On September 13, the Commission ordered the Commission Staff to file a recommendation on the status of interim Tariff No. YE-2020-0033 and the disposition of the above- captioned case. On September 23, the Staff filed its recommendation that the Commission accept the agreement GMO filed on September 12 and maintain Tariff Revision YE-2020-0033.

Tariff No. YE-2020-0033 is the result of an agreement on proposed rate schedules to adjust charges related to GMO's approved Fuel Adjustment Clause ("FAC"). GMO's FAC true-up amounts are included in the YE-2020-0033 calculations. Staff's initial

recommendations in these cases included over-collection amounts, deferral amounts and other numbers that may have been affected by the revised tariff that is to be allowed to remain in effect. The Commission will order Staff to advise the Commission of the specific true-up amounts and the dollar-amount of the effect on GMO's FAC rates per kilowatt hour, as well as any other changes that have resulted from the changes that have resulted from the filing of the revised tariff and the agreement of the parties.

#### THE COMMISSION ORDERS THAT:

- 1. No later than 9 a.m. on September 30, 2019, the Commission's Staff shall advise the Commission of the specific true-up amounts and the dollar-amount of the effect on KCP&L Greater Missouri Operations Company's Fuel Adjustment Clause rates per kilowatt hour, as well as any other changes that have resulted from the filing of the revised tariff and the agreement of the parties.
  - 2. This Order will be effective when issued.
