On September 25, 2019, the Staff of the Commission issued a Notice of Deposition indicating its intent to depose a designated representative of the Midwest Energy Consumers Group (MECG). The deposition is scheduled to take place at 9:00 a.m. on October 2, 2019.

On September 30, 2019, MECG filed a motion asking the Commission to quash that deposition, arguing that Staff's proposed deposition is not intended to elicit any relevant information, but rather is intended to punish MECG for opposing a non-unanimous stipulation and agreement entered into by the other parties to this case. The Commission will establish a time to respond to that motion.

THE COMMISSION ORDERS THAT:

1. Any party wishing to respond to the Midwest Energy Consumers Group's Motion to Quash Depositions shall do so no later than 9:00 a.m. on October 1, 2019.

2. This order shall be effective when issued.
