On September 30, 2019, Evergy Missouri West, Inc., d/b/a Evergy Missouri West (f/k/a KCP&L Greater Missouri Operations Company) submitted a letter and tariff designed to adjust its renewable energy standard rate adjustment mechanism pursuant to Commission Rule 20 CSR 4240-20.100.
