**ORDER DIRECTING EVERGY TO FILE SUBSTITUTE TARIFF SHEETS
AND SETTING TIME FOR RESPONSES**

Effective Date: October 8, 2024

On April 29, 2024, Evergy Metro Inc., d/b/a Evergy Missouri Metro and Evergy Missouri West, Inc. d/b/a Evergy Missouri West (collectively “Evergy”) filed tariff sheets to implement Evergy’s Missouri Energy Efficiency Investment Act Cycle 4. Those tariff sheets bear a January 1, 2025, effective date.

On September 27, 2024, Evergy, the Office of the Public Counsel, and Renew Missouri Advocates d/b/a Renew Missouri filed a Non-Unanimous Stipulation and Agreement (Agreement). Staff was not a signatory to the Agreement.

So that the Commission may better evaluate the Agreement, it will direct Evergy to file substitute tariff sheets reflecting the terms of the Agreement.

THE COMMISSION ORDERS THAT:

1. No later than October 15, 2024, Evergy must file substitute tariff sheets reflecting the terms of the Agreement (including a redline version denoting changes from

the April 29, 2024 tariff revisions). Those substitute tariff sheets shall bear a January 1, 2025, effective date.

2. No later than October 18, 2024, Staff shall file a recommendation addressing the compliance of Evergy's substitute tariff sheets with the Agreement.

3. Any other comments or objections about Evergy's substitute tariff sheets shall be filed no later than October 18, 2024.

4. This order is effective when issued.
