ORDER SETTING TIME FOR INTERVENTION AND RESPONSES, AND DIRECTING A STAFF RECOMMENDATION

On August 26, 2024, Union Electric Company d/b/a Ameren Missouri filed a request for a variance request under 20 CSR 4240-20.100(11) from a portion of the Renewable Energy Standard (RES) rule (20 CSR 4240-20.100(3)(J)). That rule requires Ameren Missouri to retire 90% of the Renewable Energy Credits (RECs) needed to comply with the RES requirements during the 2024 compliance year and to retire no more than 10% of the required RECs in 2025.

Ameren Missouri properly filed a notice of intended case filing and timely filed its request for variance; however, the Commission has not previously set a time for responses or for interventions. Therefore, the Commission will establish a time for interventions and responses to the variance request. The Commission will also direct the Staff of the Commission to file a recommendation.

THE COMMISSION ORDERS THAT:

1. Any person or entity wishing to intervene shall file an application to intervene no later than October 21, 2024.

2. Any responses or objections to the applications to intervene shall be filed no later than October 25, 2024.

3. Any objections or responses to the request for variance shall be filed no later than November 8, 2024.

4. The Staff of the Commission shall file a recommendation no later than November 8, 2024.

5. This order is effective when issued.
