STAFF RECOMMENDATION REGARDING COMPLIANCE TARIFF SHEETS

COMES NOW Staff of the Missouri Public Service Commission (“Staff”), by and through counsel, and for its Recommendation, states the following:

1. On October 10, 2013, the Commission issued its *Order Setting Deadline For Staff’s Recommendations And Response* (Order) directing the Staff to file its recommendation as to the new Economic Development Rider tariffs and Motion for Expedited Treatment filed by Kansas City Power & Light Company and KCP&L Greater Missouri Operations (collectively the “Companies”) no later than October 15, 2013. This Order was issued as a result of the Commission’s October 3rd *Order Approving Stipulation and Agreement* which settled matters related to the Companies’ Economic Development Rider tariffs

2. The Commission’s Energy Unit – Tariffs/Rate Design Staff has reviewed each of the tariff sheets filed by the Companies on October 9, 2013, and as substituted on October 11, 2013, and is of the opinion that these tariff sheets are in compliance with the Commission’s *Order Approving Stipulation and Agreement* as discussed in Staff’s Memorandum attached hereto as Appendix A.

3. Pursuant to the Stipulation and Agreement settling this case file, the Staff does not oppose the Companies’ Motion for Expedited Treatment.

WHEREFORE, as stated in its Memorandum, Staff recommends that the tariff sheets filed October 9, 2013, and as substituted on October 11, 2013, be approved to become effective on and after October 19, 2013:

SUBJECT: Staff Recommendation on the new Economic Development Rider and Motion
for Expedited Treatment

DATE: October 15, 2013

On October 3, 2013, the Missouri Public Service Commission (Commission) issued an Order Approving Stipulation and Agreement. This Order approved the new Economic Development Rider tariff and the frozen Economic Development Rider tariff for Kansas City Power & Light Company (KCP&L) and KCP&L Greater Missouri Operations Company (GMO).

On October 9, 2013, KCP&L and GMO filed a notice of withdrawal of the Tariff File Nos. JE-2014-0026 and JE-2014-0027 and filed new tariff sheets that reflect the tariff sheets attached to the Stipulation and Agreement to comply with the Order.

On October 11, 2013, GMO filed substitution tariff sheets to update the company name from Aquila, Inc., d/b/a Aquila Networks to KCP&L Greater Missouri Operations Company.

In its letter of transmittal accompanying the October 9, 2013 compliance filing, KCP&L and GMO request an effective date of October 19, 2013, which is less than the standard 30-day period. The tariff sheets filed on October 9, 2013, with the exception of the update to the company name, reflect the tariff sheets attached to the Stipulation and Agreement that all parties reviewed and approved.

The Commission's Energy Unit - Tariffs/Rate Design Staff (Staff) has reviewed each of the tariff sheets, filed by KCP&L and GMO on October 9, 2013, and as substituted on October 11, 2013, and is of the opinion that these tariff sheets are in compliance with the Commission's Order. Therefore, Staff recommends that the tariff sheets filed October 9, 2013, and as substituted on October 11, 2013, be approved to become effective on and after October 19, 2013.


