ORDER GRANTING MOTION FOR FURTHER EXTENSION OF TIME

On August 21, 2019, Union Electric Company d/b/a Ameren Missouri ("Ameren Missouri") filed an application with the Missouri Public Service Commission ("Commission") seeking a waiver of certain meter testing requirements in anticipation of its deployment of Automated Metering Infrastructure beginning in 2020.

Thereafter, the Commission ordered the Staff of the Commission ("Staff") to file a recommendation or a request for additional time no later than September 21, which was subsequently extended until October 8. On October 7, Staff filed a motion requesting a further extension of time to October 15. Staff, in its motion states that counsel has consulted with counsel for Ameren Missouri and represents that Ameren Missouri does not object to the request for additional time to file its recommendation.

The Commission finds that the request for additional time is reasonable and will grant it.

THE COMMISSION ORDERS THAT:

- 1. The request for an extension of time filed by Staff on October 7, 2019, is granted.
- 2. Staff shall file its recommendation no later than October 15, 2019, and sooner if able.
 - 3. This order shall be effective when issued.
