On June 28, 2019, the Commission issued an *Order Setting Procedural Schedule*, which required briefs for this case to be submitted by October 24 and October 31 by 10 a.m. for the initial and reply briefs, respectively.

On October 8, the Office of the Public Counsel filed a motion requesting a one-week extension of time to the brief deadlines due to other case obligations. Public Counsel, in its motion, stated that counsel has consulted with counsel for all parties and represents that none objected to Public Counsel's request. Based on the representation of counsel, the Commission will consider the *Motion to Modify Procedural Schedule* to be unopposed.

The Commission finds the unopposed request to be reasonable and will grant the motion to modify the procedural schedule.

THE COMMISSION ORDERS THAT:

1. The Office of the Public Counsel's *Motion to Modify Procedural Schedule* filed October 8, 2019, is granted.
2. The deadline for filing initial post-hearing briefs is extended to October 31, 2019.

3. The deadline for filing reply briefs is extended to November 7, 2019, no later than 10 a.m.

4. This order shall be effective when issued.
