On October 3, 2019, KCP&L Greater Missouri Operations Company (GMO) filed what it purported to be a stipulation and agreement between it and its steam customers resolving the issues in this case. GMO attached exemplar tariff sheets to the agreement. However, only GMO is a signatory to that agreement and GMO's customers are not parties to this case.

On October 10, 2019, the Staff of the Commission (Staff) filed an objection to the agreement. Staff stated that it only filed the objection to preserve its rights under Commission rule 20 CSR 4240-2.115 to review the agreement and the tariff sheets. Staff stated that it had not yet formed an opinion with regard to supporting or contesting the agreement, but needed additional time for review and discovery. The Commission will order Staff to file a recommendation or a status report as set out below.

THE COMMISSION ORDERS THAT:

1. With regard to the stipulation and agreement filed by KCP&L Greater Missouri Operations Company, the Staff of the Commission shall file either a recommendation or a status report indicating when it expects to file a recommendation no later than November 15, 2019.

2. This order is effective when issued.
