The parties have previously indicated that local public hearings in this matter should be held in January 2020. To assist the Commission in setting local public hearings, the Commission will direct Union Electric Company, d/b/a Ameren Missouri, the Staff of the Commission, and the Office of the Public Counsel to indicate, either jointly or separately, the recommended times and general locations for local public hearings. Additionally, those parties shall file proposed public hearing notice language.

THE COMMISSION ORDERS THAT:

1. No later than October 25, 2019, Union Electric Company, d/b/a Ameren Missouri, the Staff of the Commission, and the Office of the Public Counsel shall either jointly or separately file proposed times and general locations for local public hearings in this case.
2. No later than October 25, 2019, Union Electric Company, d/b/a Ameren Missouri, the Staff of the Commission, and the Office of the Public Counsel shall either jointly or separately, file proposed language for the local public hearing notices.
3. This order is effective when issued.
