**ORDER DIRECTING STAFF TO FILE STATEMENT CONCERNING  
TIMBER CREEK'S COMPLIANCE FILING**

The Commission granted Timber Creek Sewer Company a Certificate of Convenience and Necessity to install, own, acquire, construct, operate, control, manage, and maintain a sewer system to a single residence in an area adjoining the Oak Brook Subdivision in Clay County, Missouri. The Commission ordered Timber Creek to file 1st Revised Sheets 2A and 3A, as 30-day filings, within ten days after the effective date of the Commission's order approving the CCN. On October 14, the company filed tariff revision YS-2020-0057 to comply with the Commission's order. The Commission will direct its Staff to file a statement informing the Commission of whether the company's tariff revision complies with the Commission's order.

**THE COMMISSION ORDERS THAT:**

1. The Staff of the Commission shall file a statement regarding Timber Creek's compliance tariffs no later than October 30, 2019.

2. This order shall be effective when issued.
