**MOTION TO SUSPEND PROCEDURAL SCHEDULE**

**COME NOW** Union Electric Company d/b/a Ameren Missouri ("Ameren Missouri" or the "Company"), on behalf of the parties to this case, and requests that the procedural schedule in this case be suspended pending drafting and submission of a definitive stipulation and agreement that will resolve all issues in this case, and, in this regard, states as follows:

1.        The parties have reached an agreement in principle on all contested issues in this case and are in the process of reflecting the terms of such agreement in a formal stipulation and agreement.
2.        The procedural schedule currently calls for the filing of surrebuttal/cross-surrebuttal testimony tomorrow, Friday, October 11, 2024. The agreement to resolve all issues dispenses with the need to file further testimony.
3.        Consequently, the parties request that the procedural schedule be suspended as soon as possible, and specifically, prior to the time surrebuttal/cross-surrebuttal testimony would otherwise have been due.
4.        Counsel for all parties have authorized the undersigned counsel for the Company to indicate that they support this Motion to Modify.

**WHEREFORE**, the Company, on behalf of the parties, requests that the Commission make and enter its order suspending the procedural schedule as requested herein.
