On October 14, 2019, Spire Missouri, Inc. (the "Company"), filed the above-referenced application. The application seeks, among other things, permission and approval and a certificate of convenience and necessity ("CCN") to construct, install, own, operate, maintain, and otherwise control and manage a natural gas distribution system to provide gas service in Newton County, Missouri, as a further expansion of the Company's existing certificated area.

The Commission will direct notice of the application be given to the Newton County Commission, local newspapers, and members of the General Assembly representing residents of Newton County. The Commission will set a deadline for interested parties to intervene. The Commission will also direct its Staff to file a recommendation with regard to said application.

The Commission notes that the caption of the case has been corrected to show that the proposed service area is in Newton County.

THE COMMISSION ORDERS THAT:

- The Commission's Data Center shall provide a copy of this order and the Application to the County Commission of Newton County, Missouri.
- 2. The Commission's Public Policy and Outreach Department shall make notice of this order available to the members of the General Assembly representing Newton County and to the media serving that county.
- 3. Any person wishing to intervene in this matter shall file an application to intervene no later than November 5, 2019. The application shall be filed in the Commission's Electronic Filing and Information System ("EFIS") or with the Secretary of the Commission. Comments on the Application may also be made in EFIS.
- 4. No later than December 15, 2019, the Staff of the Missouri Public Service Commission shall file a recommendation regarding Spire Missouri, Inc.'s application for a Certificate of Public Convenience and Necessity.
 - 5. This order shall be effective when issued.

APPLICATION FOR CERTIFICATE OF CONVENIENCE AND NECESSITY AND REQUEST FOR WAIVER

COMES NOW Spire Missouri, Inc. ("Spire" or the "Company"), on behalf of its Spire Missouri West operating unit and by and through its undersigned counsel, and, pursuant to RSMo. \$393.170, RSMo, 20 CSR 4240-2.060 and Commission Rule 20 CSR 4240-3.205, requests permission and approval and a certificate of convenience and necessity ("CCN") to construct, install, own, operate, maintain, and otherwise control and manage a natural gas distribution system to provide gas service in Newton County, Missouri, as a further expansion of its existing certificated area. In support of this request, Spire respectfully states as follows to the Missouri Public Service Commission ("Commission"):

Spire West is a public utility and gas corporation incorporated under the laws of the State
of Missouri, with its principal office located at 700 Market Street, St. Louis, Missouri
63101. A Certificate of Good Standing evidencing Spire West's standing to do business
in Missouri was submitted in Case No. GM-2013-0254 and is incorporated by reference
herein for all purposes. The information in such Certificate is current and correct.

- 2 Spire West is engaged in the business of distributing and transporting natural gas to customers in Missouri as a gas corporation subject to the jurisdiction of the Commission. Spire West provides gas service in western Missouri to customers in the western Missouri counties of Andrew, Barry, Barton, Bates, Buchanan, Carroll, Cass, Cedar, Christian, Clay, Clinton, Cooper, Dade, Dekalb, Greene, Henry, Howard, Jackson, Jasper, Johnson, Lafayette, Lawrence, McDonald, Moniteau, Newton, Pettis, Platte, Ray, Saline, Stone, and Vernon. Other than cases that have been docketed at the Commission, Spire has no pending action or final unsatisfied judgments or decisions against it from any state or federal agency or court within the past three years that involve customer service or rates. Spire has no annual report or assessment fees that are overdue.

- 4. Spire seeks a service area CCN to provide gas to an individual project. This project is in Section 34, Township 27 North, Range 31 West. This project located in Newton County in Missouri. The listed section above is an area where a customer has contacted Spire with a need for a distribution system extension to service poultry operations. The legal description of the new area is set forth in the attached Appendices. Attached as Appendix 1 is a plat drawn to a scale of one-half inch (1/2") to the mile on maps comparable to county highway maps issued by the Missouri Department of Transportation or a plat drawn to a scale of two thousand feet (2,000') to the inch.
- 5. The rates for the proposed area would be those approved and in effect for the customers in the adjoining Spire West operating unit certificated areas, until such rates may be changed by approved tariff or order of the Commission. Spire estimates the addition of 4 additional customers from this project. The names and addresses of the additional customers are attached in Appendix 2. Appendix 2 has been identified as Confidential pursuant to Commission Rule 20 CSR 4240-2.135(2)(A)1, because it contains information relating directly to specific customers. Estimated revenues and expenses for the first three years of operations are shown in the feasibility study attached as Appendix 3. Appendix 3 has been identified as Confidential pursuant to Commission Rule 20 CSR 4240-2.135(2)(A)3 and 4, because it contains information relating market-specific information. No external financing will be required for construction

related to this project.

- 6 Spire holds all necessary franchises and permits from municipalities, counties, or other authorities that are required for Spire to serve the subject area. Documentation that provides assent for Newton County can be found in Appendix 4. Also included in Appendix 4 is a signed affidavit of Patti Reardon, Manager, Small Commercial and Industrial, Spire Missouri, attesting to the validity of the county assent.
- 7. Spire's experience in the operation of natural gas systems gives it the ability to provide this service in an efficient manner. For all reasons set forth herein, a grant of the application will further the public convenience and necessity.
- 8 Commission Rule 20 CSR 4240-4.017(1) provides that "(a)ny person that intends to file a case shall file a notice with the secretary of the commission a minimum of sixty (60) days prior to filing such case." No such notice was filed herein. As such, Spire seeks a wavier of the 60-day notice requirement.
- 9. Commission Rule 20 CSR 4240-4.017(1)(D) provides that a waiver may be granted for good cause. In this regard, Spire declares (as verified below) that they have had no communication with the Office of the Commission (as defined in Commission Rule 20 CSR 4240-4.015(10)) within the prior 150 days regarding any substantive issue likely to be in this case.

WHEREFORE, Spire requests, for good cause shown, that the Commission waive the notice requirement of 20 CSR 4240-4.017(1), grant a variance from the filing requirements of Commission rule 20 CSR 4240-3.205(1)(A), approve this Application, issue a CCN to Spire as set forth above and in the attached schedules, and grant such other and further relief as is just and

proper under the circumstances.


