ORDER GRANTING EXTENSION OF TIME

On September 3, 2019, William L. Hackney Jr. and Catrina Hackney (“the Hackneys”) filed a complaint with the Missouri Public Service Commission (“Commission”) against Spire Missouri, Inc. d/b/a Spire (“Spire”). The Commission then ordered the Staff of the Commission (“Staff”) to file a recommendation, which is due October 21.

On October 15, Staff filed its *Motion for Additional Time to December 5, 2019 to File Staff Recommendation*. Staff states it needs additional time to obtain replies to data requests from Spire due to the number of serious allegations and the lengthy time frame over which relevant events occurred.

Staff states that it has contacted counsel for Spire, and that Spire has no objection to Staff’s request for additional time. The Commission finds that the request for additional time is reasonable and will grant it.

THE COMMISSION ORDERS THAT:

1. The *Motion for Additional Time to December 5, 2019 to File Staff Recommendation*, filed on October 15, 2019, is granted.
2. The Staff shall submit its recommendation no later than December 5, 2019.
3. This order shall be effective when issued.
