ORDER CANCELING CERTIFICATES OF SERVICE AUTHORITY

Issue Date: October 21, 2019 Effective Date: October 31, 2019

On October 3, 2019, the Staff of the Missouri Public Service Commission filed a motion requesting Local Access, LLC's certificates of service authority to provide interexchange and basic local telecommunication service in the State of Missouri be cancelled. The Commission granted those certificates to Local Access in File No. LA-2013-0482, on June 6, 2013.

Staff states in its motion that Local Access sent a letter to Staff on September 2, 2019, indicating its desire to relinquish its certificates to provide interexchange and basic local telecommunications services. Staff indicates Local Access' request to cancel its certificates is in compliance with Commission Rule 20 CSR 4240-28.011(3), and asks the Commission to cancel those certificates.

On October 4, 2019, the Commission issued an Order Establishing Time to Respond, allowing parties until October 15, 2019, to file an objection or request a hearing. No objections or requests for a hearing were filed.

The Commission has the authority to cancel a certificate and tariff pursuant to Section 392.410.5, RSMo, which states, in part, "[a]ny certificate of service authority

may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

Based on the company's request, and Staff's motion, the Commission finds that the certificates of service authority granted to Local Access shall be canceled.

THE COMMISSION ORDERS THAT:

- 1. The certificates of authority to provide interexchange and basic local telecommunications services granted to Local Access, LLC, in File Number LA-2013-0482, are canceled.
 - 2. This order shall become effective on October 31, 2019.
 - 3. This case may be closed on November 1, 2019.
