ORDER CONSOLIDATING CASES

On September 26, 2024, Teleport Communications America, LLC (“Teleport”) filed an application pursuant to 47 C.F.R. 52.15(g)(3)(iv) requesting that the Commission review and reverse the decision of the North American Numbering Plan Thousands-Block Pooling Administrator to deny Teleport’s request for 3,000 consecutive numbers in the Jefferson City Rate Center.

The Commission created File No. CO-2025-0112 regarding Teleport’s Competitive Local Exchange Carrier (CLEC) authority and File No. XO-2025-0113 regarding Teleport’s Interchange Carrier (IXC) authority. The application and accompanying exhibits in each file are identical.

Commission Rule 20 CSR 4240-2.110(3) allows for the consolidation of cases with related questions of law or fact. Since these cases appear to involve related questions of law and fact, the Commission will consolidate the files.

THE COMMISSION ORDERS THAT:

1. File Nos. CO-2025-0112 and XO-2025-0113 shall be consolidated with File No. CO-2025-0112 being the lead case.
2. File No. XO-2025-0113 shall be closed.
3. This order shall be effective when issued.

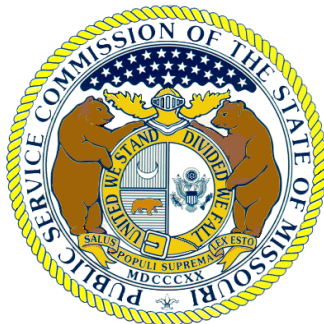
