On October 28, 2019, The Union Electric Company d/b/a Ameren Missouri filed an application for an Accounting Authority Order that would allow it to defer certain Callaway Energy Center refueling outage costs to Federal Energy Regulatory Commission Account No. 174 in the Uniform System of Accounts and to amortize those costs. Ameren Missouri also requests a waiver of the prior notice requirements of 20 CSR 4240-4.017(1). The Commission will direct notice and will establish a deadline for applications to intervene.

- 5. The Commission's Staff shall file a recommendation regarding Union Electric Company d/b/a Ameren Missouri's application no later than December 27, 2019.
