On September 3, 2019, ¹ Union Electric Company d/b/a Ameren Missouri ("Ameren Missouri") filed its *Application for Permission and Approval and a Certificate of Convenience and Necessity Authorizing it to Construct Solar Generation Facilities.* On September 3, the Commission issued its *Order Directing Notice and Setting Date for Intervention.* On October 29, Ameren Missouri filed a *Unanimous Proposed Procedural Schedule* suggesting the case be set for oral argument and evidentiary hearing on December 11-12.
