The Commission issued a Report and Order resolving this case on October 30, 2019, and later that day Spire Missouri, Inc. filed tariffs purporting to comply with the Report and Order. Along with its tariffs, Spire Missouri filed a motion asking the Commission to approve the compliance tariffs to become effective by November 12, 2019.

The Commission will order its Staff to file a recommendation about those tariffs, and will establish a time for filing responses by any other party wishing to do so.

THE COMMISSION ORDERS THAT:

1. The Commission's Staff shall file a recommendation regarding Spire Missouri, Inc.'s tariff filings (YG-2020-0069 and YG-2020-0070) no later than November 5, 2019.

2. Any other party wishing to file a recommendation regarding Spire Missouri, Inc.'s tariff filings (YG-2020-0069 and YG-2020-0070) shall do so no later than November 5, 2019.

3. This order is effective when issued.


