**ORDER DIRECTING EXPEDITED STAFF RECOMMENDATION AND
SETTING TIME FOR ANY RESPONSES TO TARIFF FILING**

On October 31, 2019, Spire Missouri Inc.'s d/b/a Spire (Spire Missouri) filed tariff sheets to reflect changes in the company's Purchased Gas Adjustment clause and Actual Cost Adjustment for its Spire Missouri East Operating Unit, and its Spire Missouri West Operating Unit. The tariff sheets bear an effective date of November 10, 2019, but the company has requested a one-time variance from Section E of Sheet No. 11.12 of Spire East's PGA Tariff, and Section 1.A. of Sheet 11.1 of Spire West's PGA Tariff so that the tariffs are allowed to take effect on November 8, 2019.

In consideration of the requested effective date of the tariff sheets, the Commission will direct the Staff of the Missouri Public Service Commission to file a recommendation on an expedited schedule. The Commission will also establish a deadline for any other entity to file a response to the tariffs.

THE COMMISSION ORDERS THAT:

1. No later than 3:30 p.m. on November 5, 2019, the Commission's Staff shall file a recommendation with regard to the tariff sheets filed by Spire Missouri, Tariff Nos. YG-2020-0071 and YG-2020-0072.
2. Any other person or entity wishing to comment on Spire Missouri's tariffs shall file a response no later than 3:30 p.m. on November 5, 2019.
3. This order shall be effective when issued.


