NOTICE OF DEFICIENCY

Issue Date: October 16, 2024

On September 26, 2024, Marquette Lumumba Mugabe Bey filed a complaint against Spire Missouri.

Commission Rule 20 CSR 4240-2.070 addresses complaints before the Commission. That rule requires the Complainant to state an alleged violation of any tariff, statute, rule, order, or decision **within the Commission’s jurisdiction**.¹ That rule further requires the Complainant to state the complaint **in a clear and concise manner**.²

The complaint cites numerous Uniform Commercial Code provisions, but does not appear to cite any tariff, statute, rule, order, or decision within the Commission’s jurisdiction, or a claim on which the Commission can grant relief. Further, the complaint is not clear and

concise enough for the Commission to discern what actions or omissions the Complainant is alleging the Respondent has made that constitute a violation. Therefore, the Commission will take no action on the complaint until these deficiencies are corrected.

Failure to comply with the Commission's rules by curing these deficiencies may result in dismissal of this complaint.³ The Respondent and the Commission's Staff are not required to file responsive pleadings unless otherwise ordered. If the deficiencies are not corrected on or before October 30, 2024, the Commission may dismiss this complaint.
