### ORDER DISMISSING COMPLAINT

Issue Date: October 16, 2024 Effective Date: November 15, 2024

On September 26, 2024, Marquette Lumumba Mugabe Bey filed a complaint against Kansas City Municipal Water.

The Commission's provisions governing jurisdiction before the Commission are found at Sections 386.020(59), RSMo. and 386.250(3), RSMo. The Commission has no jurisdiction over KC Water and so must dismiss this complaint. Further, the Commission has no jurisdiction over complaints involving, Spectrum, Google Fiber, or T-Mobile.

Under Commission Rule 20 CSR 4240-2.070(14), the Regulatory Law Judge shall cause the parties to be notified that the dismissal of Mr. Bey's complaint will be final unless an application for rehearing is filed. The application for rehearing must be filed with the Commission within 30 days.

If the Commission denies the application for rehearing, the parties then have 30 days after the denial is issued to file an appeal with the court of appeals. If the Commission grants the application for rehearing, then the Commission will order appropriate actions at that time.

## THE COMMISSION ORDERS THAT:

- 1. The Commission has no jurisdiction over KC Water and therefore dismisses this complaint.
- 2. If the Complainant wishes to request a rehearing by the Commission, such request must be filed before November 15, 2024.
  - 3. This order is effective on November 15, 2024.
