## ORDER GRANTING EXTENSION OF TIME TO FILE STAFF RECOMMENDATION

On October 8, 2024, the Commission issued its *Order Directing Evergy to File Substitute Tariff Sheets and Setting Time for Responses*. That order directed Staff to file a recommendation by October 18, 2024, about whether Evergy's substitute tariff sheets comply with the stipulation and agreement filed by some of the parties in these cases.

On October 16, 2024, Staff filed a motion for an extension of time to file its recommendation. The Commission will grant Staff's extension request and allow additional time for other comments about Evergy's substitute tariff sheets.

### THE COMMISSION ORDERS THAT:

1. Staff's motion for an extension is granted. Staff shall file its recommendation about Evergy's substitute tariff sheets no later than November 1, 2024.
2. Any other comments about Evergy's substitute tariff sheets shall be filed no later than November 1, 2024.

2. This order shall be effective when issued.
